CTI CRAs Excel

Investigative sites were surveyed about their CTI CRAs again this year. The 2010 survey was delivered to over 120 sites (up from 100 sites in 2009) and was directed to Research Coordinators that have worked with CTI CRAs in the past year. Feedback was solicited on protocol/therapeutic knowledge, teamwork, responsiveness and overall performance.

The final two questions were open-ended to assess areas of improvement needed or areas of excellence. Some feedback included the following statements:

- "Is very helpful and knowledgeable within the Study therapeutic area"
- "Is very prompt with responses to questions"
- "Is patient and understanding"
- **"Teamwork is outstanding"**
- "Is professional and well-organized"
- "Goes above and beyond the call of duty"
- "Is one in a million"
- **"Is the best I have worked with in 15 years of research"**

The survey was again well received by the sites and the response rate was outstanding (nearly 70%). The overall average rating for all attributes 1-4 was 1.29 (with 1 = Excellent and 2 = Very Good).

All constructive feedback will be incorporated into future CRA training to achieve even greater consistency and quality. The time spent by the sites providing survey feedback was genuinely appreciated and the survey results demonstrate that CTI CRAs are performing at a high level in the eyes of the sites and are truly "best in class".
