# CTI's Expanded Capabilities - Dedicated Research Sites for Phase II-IV Trials

The addition of Community Research to CTI's full service offerings include the capabilities of being a dedicated research site for Phase II-IV trials, with a strong infrastructure built around conducting trials, and methodologies for getting trials completed as effectively and efficiently as possible.

Community Research, acquired by CTI in January 2014, is a dedicated, multi-specialty clinical research site with three convenient locations throughout Greater Cincinnati, Ohio. Community Research conducts 50-60 Phase I-IV clinical trials annually in a variety of therapeutic indications, including internal medicine, dermatology, psychiatry, and sleep disorders, as well as trials in healthy volunteers. Since its inception nearly 20 years ago, Community Research has completed nearly 700 clinical trials.

Having Phase II - IV site capabilities allows our sponsors the unique advantage of continuing their clinical initiatives within Community Research under the same study staff and SOPs throughout all phases of development. Being a dedicated research site, there is a strong site infrastructure built that permits diversification and allows the research sites to conduct a variety of trials, including early and late phases of the same study. Many research sites do not have dedicated Quality Assurance departments to ensure trials are being conducted properly. Additionally, each site at CR has trained investigators and experienced clinical research coordinators, along with a Regulatory department that allows clinical staff to focus on the patients instead of the paperwork. We have a dedicated Recruitment Department focused on quick and complete enrollment of all our clinical trials. A customized recruitment plan is implemented for each trial that identifies patients through our in-house database, various media outlets and our network of area physicians. Furthermore our team is committed to identifying new participants daily and supplementing our recruitment database by over 4,750 potentials patients per month. Our Recruitment department can help with increasing study exposure to potential patients and creating a customized plan for successful enrollment.

Ultimately, our Phase II-IV site capabilities create opportunities for our sponsors to continue to work with us through the drug development process, from Phase I through post-approval.
